**FEAST DAY** is Saturday 25<sup>th</sup> June and, as usual, there will be a host of activities and entertainment of both music and action. Check out the list of stalls and presentations and decide on your programme for the day.

The main feature of the day's activities will be series of medieval re-enactments by Black Knight Historical including dance and music, archery (see above) and a fighting display.. During the day, some one hundred stalls will be operating and a full programme will be taking place on the stage and in the arena. Local schools will be presenting gymnastics and dancing displays and there will be performances by David Meacock, Trapdoor Drama, Urban Pulse, gerrards Cross Rock Choir and others. Vintage cars, Punch and Judy and a funfair will also be present.

Top Rolling Stones tribute band, the Rollin Stoned, will headline the evening concert. In addition, top Thin Lizzy tribute band Pheel Lizzy will be supporting.

Sponsorship and advertising packages are still available, as are stalls. Around 60% of pitches have currently been sold for what will undoubtedly be the local event of the year. Around 6,000 people attended in 2010 and, given similar good weather, the organisers are hoping for at least a similar number this time.

While the entire day's activities are free to attend, it is hoped that visitors will be generous in donating money and local charities will benefit from profits made. **CHANGE4CHALFONT Film Screening in Chalfont St Peter - 'The Economics of Happiness' (67 mins) Friday 3<sup>rd</sup> June at 8pm in the Parish Church Hall, Church Lane, Chalfont St Peter**

What makes us happy? Does material wealth = well-being? Economic globalisation has led to a massive expansion in the scale and power of big business and banking. It has also worsened nearly every problem we face: financial instability and unemployment; climate chaos and species extinction; fundamentalism and ethnic conflict. On a personal level it has led to life becoming increasingly stressful. The majority of us have less time for friends and family and face mounting pressures at work.

This newly released film prompts us to rethink our economic structure. Featuring interviews with thinkers and activists from every continent, it tells us that climate change and fossil fuel depletion give us little choice: we need to localise. The good news is that doing so will not only reduce our impact on the planet but also restore our own sense of well-being. So can going local solve global crises? Buckinghamshire County Council, along with partners, will be hosting a family fun day with an evening concert. The event takes place at Aylesbury Rugby Club, 11am until 11pm and the Armed Forces and the general public are invited to an entertainment packed day.

Buoyed by their Eurovision ovation, chart-topping band Blue left Dusseldorf with Buckinghamshire's Armed Forces Day celebrations firmly in their minds. Blue, who will top the bill in a 20-strong line-up of bands and performers at the event, are expected to perform "I Can", the Eurovision number that reaped them their respectable 100 points.

The band's Duncan James told Mix 96 radio presenter Danny Cox in an exclusive interview that Buckinghamshire's Armed Forces Day was high on their agenda. 'We can't wait!' said Duncan. 'We're going to be doing four or five tracks, and we just can't wait to come out there to see you guys, and we hope everyone will come and support the day. It's a great day.' And Blue are no exception. Singer Lee Ryan said: 'We want to support the lads out there. It's an amazing thing to be asked to do something like this and hopefully the crowd will enjoy being there to support them.'

The arena and day stage will feature acts such as...The Wycombe Male Orpheus Choir, Fiona Harrison 'A Voice in a Million' and The Melton Mowbray Toy Soldier band.

The evening stage will feature the headline act Blue, as well as up and coming bands Two Spot Gobi and GoGoBot will perform alongside Gemma Aguilar, finalist of Open Mic UK 2009 and locals bands LeCarla, The Outcast band will be on stage.

The live tent will feature...Live cookery demonstrations with a celebrity chef, BBC's Lynne Davies from Dog Borstal offering a Question & Answer session and a magician.

The afternoon will also feature an Air Display with flyovers from a Battle of Britain Spitfire and a Hurricane amongst others.

Broadcaster Sir Terry Wogan, a Deputy Lord Lieutenant of Buckinghamshire, who has given his support to Blue's appearance, said: 'It's an opportunity for all of us to show our appreciation of the immense contribution our soldiers, airmen and sailors have made to preserving the country's freedom, and our way of life.'

**THIS** is a Community Message from Amersham Watch Office on Tuesday, 31 May 2011. There are a couple of hoax emails doing the rounds at the moment to be aware of.

### **Outline**

Email, purporting to be from the UK's HM Revenue & Customs, claims that the recipient has paid too much income tax and should follow a link to arrange a refund.

### **Brief Analysis**

The email is not from HM Revenue & Customs (HMRC). The message is a phishing scam designed to steal personal and financial information from recipients. The link in the email opens a bogus website designed to resemble the genuine HMRC website.

HMRC will never send tax refund notifications via email. Nor will it ask taxpayers to disclose personal or financial information by following a link or opening an attachment in an unsolicited email.

### **Outline**

Email, purporting to be from Hotmail, claims that, due to several unsuccessful login attempts, the recipient's Hotmail account will be deactivated within 24 hours unless he or she logs in via an "activation link".

### **Brief Analysis**

The message is not from Hotmail. The email is a phishing scam designed to steal login details from Hotmail account holders.

Those who fall for the ruse and follow the link in the message will be taken to a fraudulent website and asked to enter their username and password.

**YOUTH** clubs and other activities in Buckinghamshire are poised to join the Big Society, if recommendations going before the County's Cabinet are agreed.

Cabinet is being asked to endorse provision of universal youth services to the voluntary sector and local communities, and agree to providing 25-year leases at peppercorn rents to 15 youth projects operating



in council-owned premises.

If agreed, this move will provide the security of tenure community-led youth projects will need in the future to apply for external funding.

The County's Youth Service provides targeted and specialist youth services, while what is known as universal youth services - clubs and other activities open to all young people - will be run by volunteers and local communities, with support from Buckinghamshire County Council during a transition period while newly-formed committees find their feet.

Feedback from last autumn's Bucks Debate, a wide-reaching public consultation process, identified youth clubs and activities as among the five top things people felt local communities could help provide, and further consultation with existing voluntary management committees supported this. Given appropriate support and guidance with obtaining funding, training and advice, the management committees felt they would be able to maintain youth projects, at a time when council budgets are coming under increasing pressures.

Steven Adams, Buckinghamshire's Cabinet Member for Education, said: "This is an exciting time for youth services, which offer so much to our young people. Councils all over the country are having to find different ways to stretch their money, and it just goes to show where there's a will to maintain these projects, there's a way. I have every confidence youth clubs in this county will go from strength to strength with the central service offering specialist provision while volunteers, with our initial support, supply that wider demand." BCC's Youth Service will continue to work with young people through outdoor education and adventure activities, accredited schemes such as the Duke of Edinburgh and Arts Award schemes, counselling, information and support, mentoring, youth councils, apprenticeships and youth work training.

**THE** latest NHS reform proposals provide a once in a generation opportunity to develop better, more integrated health outcomes for local residents. That's the view of Patricia Birchley, Buckinghamshire County Council's Cabinet Member for Health and Wellbeing.

The proposals, which are set out in the Government's Health and Social Care Bill, have been the subject of intense debate during the recent temporary pause in the passage of the Bill and the associated 'listening exercise'.

Cllr Birchley said: "We all know how important it is that this Bill is fit for purpose and I hope that this period of reflection has helped galvanise thinking around how the reforms can best address the need for a truly integrated approach to health and social care delivery, where the focus is firmly on improving health outcomes through locally made solutions.

"The reforms present us with the opportunity to more fully integrate the work and services provided by health, public health and social care, and this must be a good thing both in terms of improving services and delivering value for money. I am convinced that new legislation is vital to make sure this chance is not wasted, and that decades of council experience and expertise in public health and social care, which we can bring to the table, is not ignored.

Cllr Birchley continued: "Buckinghamshire County Council has supported the proposals contained in the Health and Social Care Bill, particularly those that increase local accountability and involvement including the establishment of Health and Wellbeing Boards. I acknowledge that GPs, the NHS and local councils have been doing a great job, but like any area, improvements can be made.

"Locally, we are already working in partnership and building important links with Health colleagues, particularly the three GP Collaboratives across Buckinghamshire. This work is important and we will be developing a new and locally devised model that is suitable for Buckinghamshire, and not a one-size-fits-all top-down approach. Our new Health and Wellbeing Board has recently held its inaugural meeting, and we are building knowledge and understanding around local commissioning arrangements so, in the future, we can co-ordinate public money in health and wellbeing to optimum effect.

"Whatever the final shape of the Bill, it is clear that in future all parts of the public sector will need to work together more closely across the whole spectrum of health and wellbeing. I also look forward to the power and strength of local accountability being firmly and fully acknowledged in the final legislation."
